PART 3 EXECUTION

3.1 INSPECTION

- A. Do not begin installation until substrates have been properly prepared.
- B. If substrate preparation is the responsibility of another installer, notify Architect of unsatisfactory preparation before proceeding.
- C. Verify proper power supply and fuel source are available.

3.2 PREPARATION

- A. Clean surfaces thoroughly prior to installation.
- B. Prepare surfaces using the methods recommended by the manufacturer for achieving the best result for the substrate under the project conditions.

3.3 INSTALLATION

- A. Install in accordance with manufacturer's instructions and requirements of authorities having jurisdiction.
- B. Use manufacturer's guidelines for minimum clearances to combustibles, walls, and finishes.
- C. Anchor all components firmly in position for long life under hard use.
- D. Upon completion of installation, visually inspect all exposed surfaces. Touch up scratches and abrasions with touch up paint recommended by the manufacturer; make imperfections invisible to the unaided eye from a distance of 5 feet (1.5 m).
- E. To use the mobile app, install where a WiFi connection is available.
- F. To install with no heat, refer to user manual (PN, 7216840100), Section 8.

3.4 **PROTECTION**


- A. Protect installed products until completion of project.
- B. Touch-up, repair or replace damaged products before Substantial Completion.








Prepare a wall with a framed opening, following the dimensions in the table.

- ▲ CAUTION: This fireplace is NOT load-bearing. Ensure the opening for the fireplace is framed in such a way that the weight of the building materials will not create pressure on the top of the fireplace.
- **! NOTE:** Wiring connections are located at the back of the firebox, in the top right corner.







Install the mounting brackets to the top of the firebox with the black screws provided.
